

# Appendix I

## Incidents reported to the RSPB 2010-2015

The table shows the number of incidents reported to the RSPB each year, for the categories specified.

In 2009, the RSPB ceased recording certain categories of incidents, such as the shooting and destruction of non-bird of prey species, unless there is an associated prosecution. Therefore, the figures supplied do not give a total figure for wild bird crime in the UK and are not comparable with figures provided for years prior to 2009.

Note that the 2015 figures do not include the full annual data set usually included from RSPCA (data from 2013 onwards has been delayed but may be included retrospectively). As a result, the figures for 2015 will be lower, in particular for categories involving taking, sale and possession of non-bird of prey species.

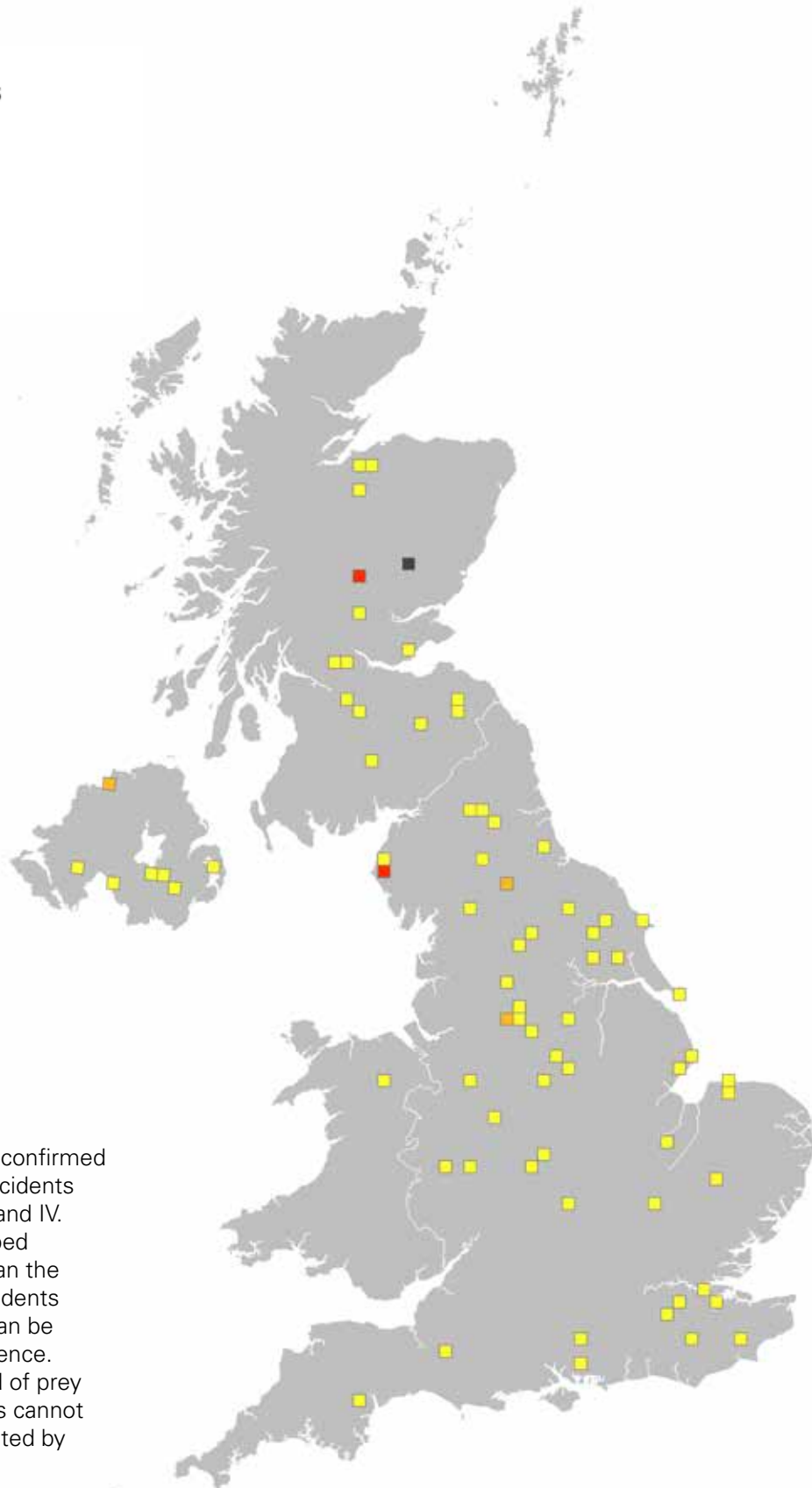
